Notice is hereby given that the Charleston County Board of Voter Registration and Elections will conduct the General Election for the Town of Lincolnvile on Tuesday, November 04, 2025. Any person wishing to vote in this election must register no later than Sunday, October 05, 2025. Voter registration by mail forms will be accepted if postmarked by Monday, October 06, 2025. If necessary, a runoff election will occur on Tuesday, November 18, 2025.
