HOW CAN I REGISTER TO VOTE?

IN PERSON



You can register to vote at our office during regular business hours.

You can also register to vote at any National Voter Registration Act agency such as the DMV, the Department of Health and Human Services, or the Department of Disabilities and Special Needs.

GET READY TO VOTE

Register to Vote or Update Your Voter Registration

1

If you're already registered to vote, make sure your registration information is up to date.

! Check your voter registration before May. To vote in an election, you must register in your county at least 30 days before Election Day.

2

Review Your Sample Ballot

Head to scvotes.gov to view your sample ballot and voting districts.

Sample ballots are available 45 days before the election.

3

Make a Plan to Vote

Where are you voting?

- Visit scvotes.gov to find early voting locations and your Election Day polling locations.

How are you getting to your polling location?

- Look up directions for driving, public transit, biking, or walking.

When are you planning to vote?

- Set a time to cast your vote!

4

Go Vote!

Make sure to bring your valid, unexpired photo ID. See scvotes.gov for more information on photo ID requirements.

CAN I VOTE ABSENTEE?

You can vote absentee if you fall under one of the following categories:

- You are physically disabled.
- You are 65 or older.
- You are a member of the Armed Forces and Merchant Marines, a spouse, or a dependent that lives with them.
- You were admitted to a hospital as an emergency patient within four days of an election or on Election Day.

You can vote absentee if you can't vote during the early voting period or on Election Day because:

- You have employment conflicts.
- You will be caring for someone who is sick or physically disabled.
- You are confined to a jail or pretrial facility pending the disposition of an arrest or trial.
- You will not be in Charleston County.

HOW DO I VOTE ABSENTEE?

1

Request an absentee ballot application.

You can request an application at our office, by phone, or by mail.

2

Receive and complete your application.

If you want to get your ballot at a different address than the one you registered with, add a mailing address.

3

Return your absentee ballot application.

You can return your application:

- By mail.
- In person at our office.



We must receive your application by Friday, May 29, at 5:00 PM.

4

Receive and fill out your ballot.

Ballots are sent out 30 days before the election. When you fill out your ballot:

- Make sure your choices are clearly marked.
- Complete all sections on the outer envelope.

5

Return your ballot.

You can return your ballot:

- By mail.
- In person at our office or any early voting center in Charleston County during early voting hours.

- Your ballot must be received by our office before 7:00 PM on Election Day.
- Postmarks do not apply for mail-in ballots.
- Absentee ballots cannot be accepted at polling locations on Election Day. If you want to return your ballot on Election Day, it must be at our office by 7:00 PM.



Audio ballot and tactile keypad

Listen to your ballot with headphones.
Use the tactile keypad to vote.



Larger text

Increase the text size on your ballot.



Increase contrast

Increase the color contrast on your ballot.



Sip-and-Puff input

Bring and use your sip-and-puff to vote with the ballot marking device.

Do you need someone to assist you in the polling place?

If you need help voting due to blindness, disability, or inability to read or write, you can request assistance from either:



Someone you know

Bring someone you know to help you at the polling place. *



Poll workers

Ask a poll worker to help you at the polling place.



Service animals

Bring your service animal to help you at the polling place.

*The person assisting you can't be your employer, an agent of your employer, or an officer or agent of your union.

VOTING ACCESSIBILITY

Can we make it easier for you while you are here?



Seating available

Ask us for a chair to sit in while waiting in line and/or voting



Line holding

Ask us to hold your spot in line so you don't have to stand for a long time.



Sensory inclusive bags

Ask us for a sensory bag that includes fidget tools, noise-cancelling headphones, and other resources. These are available only at Early Voting locations.

VOTING ACCESSIBILITY

Curbside Voting

Curbside voting offers voters who are unable to access the polling place or stand in line due to a disability or being age 65 or older the opportunity to vote in person from their vehicle.

Voters who qualify can vote curbside at their polling place on Election Day or during Early Voting at an Early Voting Center.

Just Bee Partnership

In 2024, BVRE first partnered with Just Bee to enhance accessibility at polling locations for the neurodivergent community during the statewide primaries' early voting period.

Together, we are proud to offer dedicated support and resources to our neurodivergent voters.

COUNTY-LEVEL OFFICES

Probate Judge

Handles wills, estates, and marriage licenses. Also helps with guardianships, mental health cases, and special court situations.

Four-Year Term

Register of Deeds

Records property documents like land titles and liens. Makes sure records follow federal and state law and are available to the public.

COUNTY-LEVEL OFFICES

County Council (Districts 1, 2, 5, 8, & 9)


There are 9 council members who represent different parts of the county. The council serves four-year staggered terms and are elected from single member districts.

They make local laws and set the county's goals and budget. They also approve taxes and fees to pay for services like roads, safety, and parks.

STATE-LEVEL OFFICES

Governor & Lieutenant Governor

The Governor and Lieutenant Governor run together as a joint ticket.

Governors are responsible for implementing state laws and overseeing the operation of the state executive branch. They also serve as the intergovernmental liaison to the federal government on behalf of South Carolina.

The Lieutenant Governor is the first official in the line of succession to the governor's office.

4-Year Term

Attorney General

The Attorney General serves as the state's chief criminal prosecutor, chief legal officer, and securities commissioner.

STATE-LEVEL OFFICES

Secretary of State

The Secretary of State files and examines business filings and state trademarks, maintains the state notary public database, and issues commissions for elected officials and those appointed by the Governor.

4-Year Term

Agriculture Commissioner

The Commissioner is the head of the state Department of Agriculture. They promote and oversee the state's agricultural industry, focusing on economic growth, consumer protection, and market development.

4-Year Term

Comptroller General

The Comptroller supervises state spending, keeps the state's books, and maintains accounting controls over state agencies.

STATE-LEVEL OFFICES



Superintendent of Education

The Superintendent serves as secretary and administrative officer to the State Board of Education, as well as management of all public-school funds provided by the State and Federal Government.

Treasurer

The Treasurer serves as the state's banker and is responsible for the safety and security of the state's money.

4-Year Term

State House of Representatives (124 Seats)

The State House of Representatives are part of the South Carolina Legislature. They work to create the laws that govern our state.

FEDERAL-LEVEL OFFICES

U.S. Senate (1 Seat)

The U.S. Senate forms part of the federal government's legislative branch, along with the House of Representatives. Senators have the exclusive authority to try impeachments, approve or reject treaties and presidential nominations to executive and judicial offices.

Each state elects two Senators who serve 6-year staggered terms.

1 Open Seat

U.S. House of Representatives (7 Seats)

The U.S. House of Representatives forms part of the federal government's legislative branch. Representatives have the power to impeach, introduce bills and resolutions, as well as offer amendments and serve on committees.

This is a districted office, with each member representing individual districts, that has a 2-year term.



FREQUENTLY ASKED QUESTIONS

What are Statewide Primary Elections?

Statewide Primary Elections are used by the Democratic and Republican parties to determine which candidates will run for their state's partisan offices in the **November 3, 2026, General Election.**

Did you know?



Other political parties determine which candidates will run for their state's partisan offices through conventions.

Do I Register by Party in South Carolina?

No, in South Carolina voters do not register by party. The state holds open primaries.

For a primary, voters may choose either a Democratic or Republican ballot—not both. If there is a runoff, voters do not need to have voted in the primary to participate; however, if they did vote in the primary, they may only vote in the runoff for the same party.



If you choose a party's primary and that party does not have a candidate running for a specific office, you will not have a candidate to vote for in that race.

For example, if you choose the Democratic primary and they do not have a candidate for Probate Judge, you will not be able to vote for that office.

FREQUENTLY ASKED QUESTIONS

Can I write in a candidate?

No, write-in votes are not allowed in political party primaries.

What is the difference between partisan and nonpartisan?

For partisan offices, candidates must be affiliated with a political party to run.

For nonpartisan offices, candidates are not affiliated with a political party, and there are no party primaries.

What are open and closed primaries?

Open Primary

- Voters may vote in any party's primary.
- Voters cannot vote in more than one party's primary.

Closed Primary

- Only voters registered with a given party can vote in that party's primary.
- States with closed primaries include party affiliation in voter registration.

The state of South Carolina holds Open Primaries.

FREQUENTLY ASKED QUESTIONS

What does “at-large” mean?

When an office is elected at-large, everyone in the town or city can vote for a candidate. If the office is districted, only people living in that specific district of the town or city can vote.

What is a runoff election?

In South Carolina, cities and towns can choose one of two methods to decide the winner of an election: majority or plurality.

Majority Elections

Majority elections can be decided in one of two ways:

1. For districted offices, a candidate needs to get at least 50% of the vote plus 1 additional vote.

If two candidates are running for City Council District 2, and Candidate A receives 582 votes and Candidate B receives 581 votes, then Candidate A wins.

2. For at-large offices, candidates must receive more votes than the result of this formula:

$$\text{Total number of votes} \div \text{Number of seats} \div 2$$

If 234 people voted in an at-large election, assuming three open seats:

$$234 \text{ total number of votes} \div 3 \text{ seats} \div 2 = 39$$

Each candidate needs to receive more than 39 votes to get a majority.

If no candidate gets a majority, a runoff election will be held two weeks later.

FREQUENTLY ASKED QUESTIONS

Plurality Elections


In a plurality election, the candidate does not need to get a majority of the votes.

The person with the most votes wins, regardless of whether they have over 50% of the votes. Runoffs do not occur unless there is a tie.

Majority Elections - Potential Outcomes (Districted Offices)

Runoff Election

In the example below, no candidate won a majority of the voter.



The election winner would be decided in a runoff between the top two candidates, Blue and Orange.

FREQUENTLY ASKED QUESTIONS

Majority Elections - Potential Outcomes (Districted Offices)

No Runoff Election

In this next example, Red won a majority, so Red is the winner. No runoff election needed.

Runoff elections are more common in primary elections and municipal elections.



Plurality Elections - Potential Outcome



In a plurality election, the candidate with the most votes wins.

In the example to the left, Orange got 42% of the vote and the other candidates got less. Orange wins.

For plurality elections, there are no runoff elections, no matter how many candidates are running.

FREQUENTLY ASKED QUESTIONS

What is a Districted Office?

Districted offices are offices where some or all members of the governing board represent specific districts within a city. Only voters who live in a particular district may vote for candidates running for the seat representing that district.

Head to scvotes.gov to view your voting district.
