

Mail

Juveniles can receive mail on a normal basis. Oversized cards larger than 9x8 will not be accepted. Juveniles can hold onto their Legal Mail.

Incoming and outgoing mail will be inspected for contraband. Any mail found to contain contraband will be held by the facility and may serve as the basis for disciplinary or criminal charges.

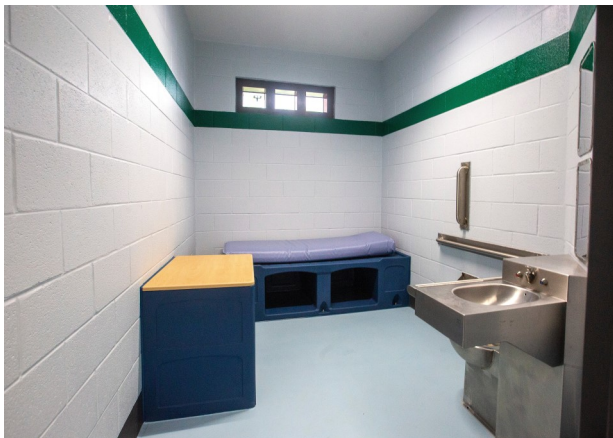
PREA

PREA (Prison Rape Elimination Act)

The CCJDC has a “ZERO-TOLERANCE” policy against sexual misconduct, sexual assault, consensual sexual contact, sexual abuse, sexual coercion, rape and/or sexual harassment by any juvenile towards another juvenile or any staff member.

Visitation

Visitation can be scheduled in advance through the Juvenile Administrative Assistant. Walk-ins are accepted on a case-by-case basis. **Visitation sessions are 30 minutes.**

Juveniles in Disciplinary segregation are allowed one visit per week, either Sunday or Saturday for thirty minutes.

Hours

Hours of visitation are:

Tuesdays and Thursdays: 6:30—8:00 p.m.

Saturdays: 2:00—4:00 p.m.

Sundays: 1:00—3:00 p.m.

Professional Visitation (Mon-Fri)

8:00 — 11:00 a.m.; 1:00—5:00 p.m.; 7:00—9:00 p.m.

*Weekends by appointment

Juveniles will not be discussed over the phone pursuant to SC Code of Laws 63-19-2030. Parents/Legal Guardians must come directly to CCJDC to acquire information regarding their child.

Visitor Rules and Regulations

1. All visitors must have a valid picture ID.
2. Visitors under the influence of alcohol and drugs will not be admitted.
3. Only parents, legal guardians, legal representation, and grandparents may visit juveniles during visitation hours.
4. Visitors may not bring additional family members to include children, cousins, or other distant relatives.
5. Visitors may not give or receive anything by any juvenile.

6. All visitors are subject to being searched.

7. Eating, drinking or smoking is not allowed in the visitation areas.

8. The use of cameras, cell phones, electronics or recording equipment without the consent of the Chief Deputy, or designee is strictly prohibited.

Medication

Glasses and prescription medication for juveniles are only accepted with the contracted medical company's approval.

Library

The dedicated library space has over 400 new books including fiction, non-fiction, graphic novels and books in Spanish. There are also dictionaries, almanacs, biographies, and GED prep resources. Charleston County Juvenile Detention partnered with the Charleston County Public Library to create a unique juvenile experience and increase readership. CCPL will add more books based on their interests.



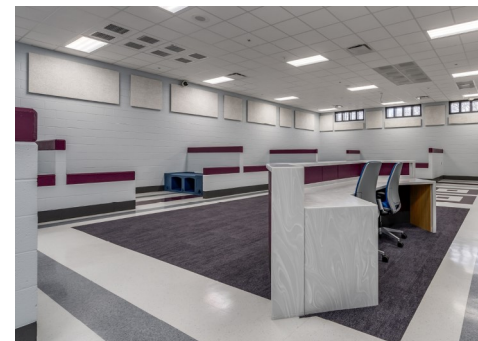
Money Release

The money taken and deposited during the intake process can be released from the juvenile's account to assist with the payment of fines and/or bondable charges. The money must be picked up by the legal guardian/parent at the main jail lobby.

Once other deposits have been made to the account, no funds may be released, except to bondsmen or attorneys.

Leaving Money

Money may be deposited into a juvenile's canteen account by using the kiosk machine located in the Sheriff Al Cannon Detention (SACDC) Lobby 24 hours a day, by sending money orders through the U.S. Mail **(Do not send cash or personal checks)** or depositing funds directly to the inmate's account by going to www.gtlfsonlinepay.com. All money orders should be made out to the Charleston County Juvenile Detention Center. The juvenile's name and number must be placed on the memo line of the money order.



Juvenile Commissary

Juveniles can order commissary once a week. A maximum of one hundred dollars can be spent each week on commissary. All commissary items will be stored in the juvenile's bin. In the event a juvenile is released prior to receiving commissary, a refund will be issued within five business days after release. A legal guardian and/or the juvenile may pick up the refund check at the SACDC lobby.

Adults can put money onto a juvenile's account through gtlfsonlinepay.com (use facility code 229405), or by using the kiosk in the lobby of the Sheriff Al Cannon Detention Center.

Initial Call

Each juvenile is provided two (2) intake phone call within 24 hours of confinement.
