Charleston County Winter Weather Update #4

County offices and facilities, including courts, will open at 12 p.m. Monday

Charleston County returned to OPCON 3 and deactivated the Emergency Operations Center at 1 p.m. today.

County offices and facilities will reopen for normal business at 12 p.m. Monday. This includes all county Convenience Centers and [Charleston County Public Library](#) branches and offices.

The Bees Ferry Landfill will open at 9 a.m. Monday. An announcement regarding the Materials Recovery Facility's reopening will be made later today.

The Charleston County Judicial Complex will open at 12 p.m. Monday, and afternoon hearings will proceed as scheduled.

Per the Chief Judge for Administrative Purposes, jurors scheduled to report for the Court of Common Pleas and General Sessions **should now report at 12 p.m. instead of 9 a.m.** to the location indicated on the original summons.

Early voting for the City of Folly Beach Special Election will take place from 12 p.m. to 5 p.m. Monday at Board of Voter Registration and Elections headquarters, located at 4340 Corporate Road in North Charleston.

The Virtual Probate Workshop planned for 10 a.m. tomorrow will take place as scheduled.

Warming Center Information

The City of Charleston's warming center located at Shaw Community Center (20 Mary Street) will remain open until 7 a.m. Monday. It will reopen Monday evening at 7 p.m.

Additionally, the following privately-operated area warming centers will open tonight:

- **Holy City Mission at Aldersgate Methodist (1444 Remount Road, North Charleston)**

- Admission Hours: 7 p.m. to 9 p.m. (no pets)
- Transportation: Board CARTA Route 13 and get off the bus at Remount Road and Allison Avenue Bus Stop and go to Aldersgate Methodist Church from there.

- **Seacoast Church Summerville (301 East, 5th North Street, Summerville)**
 - Admission Hours: 7 p.m. to 10 p.m. (accepting pets)
 - Transportation: Board CARTA Route 10 outbound at either Meeting Street/Sheppard Street or Meeting Street/Johnson Street and inform the driver you are going to the warming center. Then, transfer to Tri-County Link at T-Mobile (8751 Rivers Ave). Pick-ups from that stop at 4:10 p.m., 5:16 p.m., and 6:30 p.m.

- **Seacoast North Charleston Dream Center (5505 North Rhett Avenue, North Charleston)**
 - Admission Hours: 7 p.m. to 10 p.m. (no pets)
 - Transportation: Accessible via CARTA (Stop #416 at N. Rhett/Sumner Ave.)
 - Warming Center entrance is located behind Dream Center building, accessible via walkway under awning.
- **Hibben United Methodist (690 Coleman Boulevard, Mount Pleasant)**
 - Doors will open at 6 p.m. on Saturday. Sunday's opening hours will depend on weather conditions and transportation impacts. (no pets)
 - Transportation: Accessible via CARTA (Stop #744 at Coleman Blvd/Simmons St.)
